His most recent publications on Jewish themes are Brym, R., Slavina, A. and Lenton, R., Qualifying the leading theory of diaspora Jewry: an examination of Jews from the former Soviet Union in Canada and the United States, *Contemporary Jewry* (40, 2:2020), and a translation from the Yiddish of Yakov Leshchinsky's 1928 essay, The development of the Jewish people over the last 100 years, *East European Jewish Affairs* (50, 1/2: 2020).
