Zachary M. Baker is the Reinhard Family Curator Emeritus of Judaica and Hebraica Collections in the Stanford University Libraries. Previously, he served as Head Librarian of the YIVO Institute for Jewish Research (New York City) and as Head of the Yiddish Department and Technical Services at the Jewish Public Library (Montreal). He is a member of the core research team of the <u>Digital Yiddish Theatre Project</u> and is on the Board of Directors of <u>In geveb</u>: A Journal of Yiddish Studies. As reflected in his publications, his research interests include Judaica librarianship, Yiddish bibliography, Holocaust bibliography, Yiddish theatrical history, and Jewish culture in Eastern Europe. He is the editor of *Judaica in the Slavic Realm, Slavica in the Judaic Realm: Repositories, Collections, Projects, Publications* (2003), and *Ira Nowinski: The Photographer As Witness* (2004).

Robert Brym, FRSC, is SD Clark Professor of Sociology and an Associate of the Centre for Jewish Studies at the University of Toronto. His forthcoming works include Robert Brym and Randal Schnoor, eds. *The Ever-Dying People? Canada's Jews in Comparative Perspective* (Toronto: University of Toronto Press), articles on the politics of Canadian Jews from the former Soviet Union and on Jewish migration to and from Canada, Argentina, and Israel, and a translation of Yakov Leshchinsky's *Jewish Economic Life in Yiddish Literature*, with Eli Jany.

Judith Cohen is an ethnomusicologist, medievalist, singer and storyteller. Both as a scholar and as a performer, she works with Sephardic music and related traditions, including medieval music, music among Crypto-Jews of rural Portugal, Ashkenazi vocal and instrumental music, and traditions of the Balkans, Spain, Portugal and French Canada. She teaches part-time at York University and is the consultant for the Alan Lomax Spain collection.

Yolande Cohen est professeure titulaire d'histoire contemporaine à l'Université du Québec à Montréal. Chevalier de l'Ordre de la légion d'Honneur de France et Chevalière de l'Ordre National du Québec, elle a reçu un doctorat Honoris Causa de l'Université de Montréal en 2019.

Jean-Philippe Croteau est professeur à la section française de l'Université de Tokyo des études étrangères au Japon. Détenteur d'un doctorat en histoire, il est l'auteur de nombreux articles et contributions sur l'histoire de l'éducation, la communauté juive de Montréal et la minorité franco-ontarienne. Il a publié un livre sur l'intégration des immigrants à l'école, *Les commissions scolaires montréalaises et to-*

rontoises et les immigrants (1875-1960). Il est aussi co-auteur de deux ouvrages sur la conscience historique des jeunes francophones au Canada, L'avenir du passé, Identité, mémoire et récits de la jeunesse québécoise et franco-ontarienne et Beyond History for Historical Consciousness: Students, Narrative, and Memory.

Yoni Goldstein is the CEO and Editor-in-Chief of The Canadian Jewish News. His work has also been published in *The Globe and Mail, The National Post, Maclean's, The Walrus, The Jerusalem Report, Ha'aretz* and *The Wall Street Journal*.

Kenneth Grad is a lawyer and Ph.D. candidate at Osgoode Hall Law School. His dissertation explores the utility of the criminal sanction as a tool for combatting hate speech and Holocaust denial. Before pursuing his doctorate, he served as a law clerk to Justice Morris Fish of the Supreme Court of Canada and practised criminal law in Toronto.

Jews, Canada, and the Sense of Belonging* (University of Toronto Press, 2021). He serves as the associate director of York's Israel & Golda Koschitzky Centre for Jewish Studies, and the editor-in-chief of the journal *Canadian Jewish Studies / Études juives canadiennes*.

Leora Schaefer is the Executive Director of Facing History and Ourselves, Canada, an organization that engages teachers and their students in the study of history through an approach that encourages critical reflection and active citizenship. Leora facilitates seminars and workshops on teaching practice and pedagogy and works with all levels of education, from Ministries of Education to School boards and schools across the country. She has a Bachelors in Education from the University of Winnipeg and Masters of Arts in Jewish Communal Leadership and Near Easter and Judaic Studies from Brandeis University.

Stephen Schaefer was born in Roseburg, Oregon, the United States, a small town named after a Jewish man, Aaron Rose, whose homestead in the mid 19th century became the Town of Roseburg. Roseburg had two Jewish families when Stephen lived there. Stephen moved many times while growing up, because his father worked as a doctor for the Veteran's Hospitals in the United States. Stephen immigrated to Canada with his Canadian wife Evelyn after they lived in Israel from 1972 – 1974. They lived in Winnipeg, Manitoba for 37 years where Stephen worked as a school social worker. His volunteer work included the Israel Experience Committee for many years. Stephen and Evelyn raised their children, Leora and Ari, in Winnipeg. Stephen and Evelyn moved to Toronto, to be close to their children and grandchildren who had settled there. They have four grandchildren.
